 - Early May moving onto the community legacy campaign shortly Minimum donation of \$10K to be listed on the donor wall

Phil R.:

- Hired a Communications Specialist in November 2022 (Samantha)
- Launched a newsletter
- Launched Social Media accounts (Facebook, Instagram and Twitter)
 - Building an audience via Social Media and Communications
- Attendance at local events e.g. Home Show, Street Festival, Farmer's Market to share project information with local residents
- Presented design renderings
- Hosting hard hat tours
 - Now open to community groups
 - There are also opportunities for volunteers
- Conducting downtown walks for Phil/Samantha to introduce themselves and the project to downtown businesses
- Plan to offer \$100 gift certificates to downtown businesses

Richard G.:

Requested more information about the Café's operating hours.

Phil R.:

- The assumption is that they will be open for at least 70 hrs/week or more.
- He is flexible based on the proposals of potential vendors.
- It would be ideal if their hours covered those of the Square i.e. open and available at the same time as the Square and into the evening if/when there is an event in the Square.

Marilee H.:

• Requested a budget update.

Phil R.:

- \$51.3M Capital Budget
- The project is currently on budget
- o The project is 75% 80% complete
- \$240K Operating Budget (2019)
 - \$720K budget plateau
 - Unspent funds go into the Stabilization Funds
 - Staffing costs e.g. Facility Operator, Customer Service. I.T. Specialist to be hired in 2023



Marilee H.:

 Noted that reaching out to the local residents for donations was problematic as there was sensitivity around the financial investment in the project, especially in reference to the impact of Covid on the community at large.

Phil R.:

The community campaign is scheduled to be launch in June/July

Marilee H.:

• Enquired whether the RFP for the Café (on the square) could be targeted to local businesses in Aurora?

Lisa H.:

- The RFP for the Café (on the square) cannot only/primarily target at any one audience/stakeholder as it has to be open and an available to all viable candidates.
- One approach to promoting this business opportunity is to host an event in order to showcase the project and this opportunity to e.g. senior executives.

Director, Planning & Development Services and



Finance) to be managed through the Economic Development operating budget. For the upcoming update to the Economic Development Strategic Plan, funding/budget considerations should be discussed prior to the next annual budget process for 2024.
